Today, Richmond County Hospice, Inc. has an arm in Anson County, Anson Community Hospice, the only General Inpatient Unit in Richmond County, Hospice Haven, and also serves patients in Montgomery, Scotland, and Moore Counties.

CAMP HAVEN 2015







Fifty-one campers participated in our grief camp, Camp Haven, which was held on Wednesday, April 22, 2015. With the help of 90 volunteers, the staff of Richmond County Hospice, Inc., hosted a day of fun and reflection. This was our twenty-fifth year of sponsoring a grief camp for children in the community who have experienced a loss through death, divorce, or separation. Camp Haven provides a safe place for kids to explore their feelings of grief as well as have fun with other children who share similar circumstances of loss.

The day started with the campers receiving a Camp Haven t-shirt and a gym bag. They then enjoyed breakfast and a parachute ice breaker activity. Following this, the campers were divided into age groups and participated in ten different activities. Children made "emotion" bracelets, drew pictures on quilt squares, wrote a poem and love note, made a memory box, and designed a scrapbook. Campers also planted flowers, made a bird feeder, discussed the Cycle of Emotions, and made pillows from their loved one's shirts. There was a recreation station which included cornhole, bouncy house, Frisbee, and free play which allowed the campers to be active and to release some energy. The campers enjoyed a delicious lunch and afternoon snacks . The final activity of the day was a balloon release giving the children the chance to say good-bye to their loved one. Parents were invited to participate in the balloon release.

Many friendships were made and much grief was shared during the camp. Many businesses, churches, and organizations helped in making the camp a success. A Look from the Outside into your Hometown Hospice

Many of us travel up and down the busy US Hwy #1 and pass the campus of Richmond County Hospice, looking over to admire the grounds so neatly maintained, not even knowing what this organization does. Others pass by looking over with feelings of gratitude, admiration, comfort and peace as they or someone they love has had the opportunity to experience firsthand what hospice is all about. Hospice is defined as: care designed for people in



the final phase of a terminal illness and focus on comfort and quality of life, rather than a cure.

For myself personally, after working in hospice care for seven of my thirteen years as a nurse, hospice is so much more than a job. It's a commitment to making an impact in the lives of the patients. Fortunately for myself, the foundation of my hospice experience began right here with my hometown hospice, Richmond County Hospice, Inc. Serving as Nurse Care Manager for patients in your hometown was rewarding. Patients and their families know you and never forget the impact you and the organization had on their lives at such a difficult time.

Being a hospice nurse is so rewarding and fulfilling, however, it can also be challenging. Having a strong supportive team is not only the essential part in managing the care of the patient, but the family as well. It is also necessary to have strong, nurturing, supportive, and knowledgeable administrative leaders who manage the daily operations of the organization.

The presence of a full time, in-house Medical Director is essential in overseeing the clinical aspect of the organization required by Medicare. The clinical aspect includes directing patient care, providing formal rounds at the in-patient facility, face to face visits to home care patients, home visits, skilled consultations to the hospice staff, and cost containment activities.

Over the last few weeks, I have had the privilege of completing my Community Health Clinical Hours at Richmond County Hospice as I work toward obtaining my Bachelors Degree in Nursing. Richmond County Hospice is a non-profit organization serving the communities of Richmond, Anson, Scotland, Montgomery, and Moore Counties.

What I witnessed during my time there was every aspect of their operation, from an admission to home visit rounds at the Hospice Haven with the Medical Director, Dr. Steven Strobel, as well as following other clinical team members to see how their roles are crucial in assisting the nurse with providing patient centered care. Dr. Strobel, recently hired as Richmond County Hospice's first full-time, in-house Medical Director, provides plans to better serve and care for the organization's patients.

From January 1st through June 30, 2015, Richmond County Hospice served 211 patients. Of these, only 22 required a trip to the hospital. Dr. Strobel's presence decreased hospitalization by 66% from the same period in 2014. From January 2014 through June 2014, 49 of the 153 total patients served went to the Emergency Room.

Dr. Strobel's presence full-time has not only been an asset to the staff and patients by decreasing hospitalization, but has proven to be more cost effective for this non-profit organization. Providing care for patients at home or in the in-patient facility locally is so important to the patients and families as the focus continues to be patient centered care maintaining comfort and quality of life.

Richmond County Hospice, a non-profit organization provides; care to all who qualify regardless of their ability to pay. There are many elements that set Richmond County Hospice apart from other organizations. One aspect is providing services for thirty years in our community. The services are provided through a successful, ongoing ministry which includes a Benevolent Care Program. Money is raised from local community fundraisers such as the Forever Tree. Contributions of \$10 are made in honor or memory of a loved one at Christmas, then that person's name is placed on a Christmas Tree at Richmond County Hospice. One hundred percent of the gifts received help meet the needs of the Benevolent Care Program. This program includes support groups, one on one counseling, grief camp for kids, and bi annual memorial services. Richmond County Hospice supports the community in a number of other ways. The following are additional events that Richmond County Hospice coordinates.

- 1. A yearly volunteer banquet showing gratitude for all those who volunteer their time to help this organization
- 2. Camp Haven, an annual event designed for children ages 5-12 who have experienced a significant loss during the previous year. In 2015, they had the most participants ever.
- 3. Serving lunch one day a month at the local soup kitchen-donated, prepared, and served by hospice staff.

There are numerous ways to contribute to your hometown hospice. Donations may be made in honor or memory of someone, and in-kind donations are greatly appreciated. A list of needed items is available by calling or stopping by Richmond County Hospice. These items help meet the needs of the patients and families both in home care and at the in-patient facility.

In closing, my clinical hours spent at Richmond County Hospice were enriching and educational. I was very thankful for this experience and all the care that Richmond County Hospice provides to our community.

Advance Directives: Difficult, but Necessary

One of the most difficult, yet most important conversations that a family can have involves advance directives. It is important that individuals determine and discuss their wishes for treatment with family members, and formalizing them into advance directives can ease the strain placed on a caregiver when caring for a loved one. An advanced directive is a document that makes your wishes regarding medical care known to your family members and care providers. There are various forms of advance directives, not limited to the following:



- 1) North Carolina Advance Directives Packet: This document contains both a Healthcare Power of Attorney (HCPA) form as well as a Living Will. The HCPA form names the individual that you choose to make your healthcare decisions for you when you are deemed no longer competent to do so. A Living Will stipulates your wishes regarding life sustaining treatments such as artificial nutrition, hydration, and ventilator support. Executing these documents requires that the individual be alert and oriented and able to understand the decisions which they are making. It also requires that two witnesses, not related by blood or marriage, witness the individual's signing of the document. A notary public is also present during the signing of these documents. Individuals also need to ensure that these documents are provided to healthcare providers and the appropriate family members to ensure that their wishes are honored.
- 2) Five Wishes: This document addresses five key areas concerning end-of-life medical care:
 - Who do I want to make my medical decisions for me if I no longer can do so?
 - What kind of treatment do I desire?
 - How comfortable do I wish to be?
 - How would I like other to treat me?
 - What would I want my loved ones to know?

This document also requires a notary public be present along with two witnesses. Again, it is necessary to ensure that healthcare providers and appropriate family members are provided with a copy of this form.

- 3) Medical Orders for Scope of Treatment (MOST) form: Recently, this form has become increasingly recognized by our state. The MOST form addresses several areas, including resuscitation status, antibiotics, and medically administered fluids and nutrition. This document requires a physician's signature, as well as that of the individual. The MOST form must be reviewed with a physician at least annually.
- 4) **Do Not Resuscitation (DNR) form:** This form is appropriate for individuals that do not wish to undergo Cardiopulmonary Resuscitation or CPR. In order to be valid, the original "goldenrod" colored form must be present to prevent CPR from being administered by first responders. This form requires a physician's signature and is typically completed by the individual's primary care doctor. As with other documents, it is important to ensure that healthcare providers and family members are informed of the DNR status for the individual.

Conversations regarding such topics can be uncomfortable for family members. However, it can also be a very important gift to allow your loved ones to know that they are honoring your wishes. 








The Friends of the Hamier Library came to the Hospice Haven. They will replenish the books monthly. We are so thankful for these generous ladies and this great program.






Our Dedicated Volunteers
