Richmond County Hospice Forever Tree Lighting Ceremony



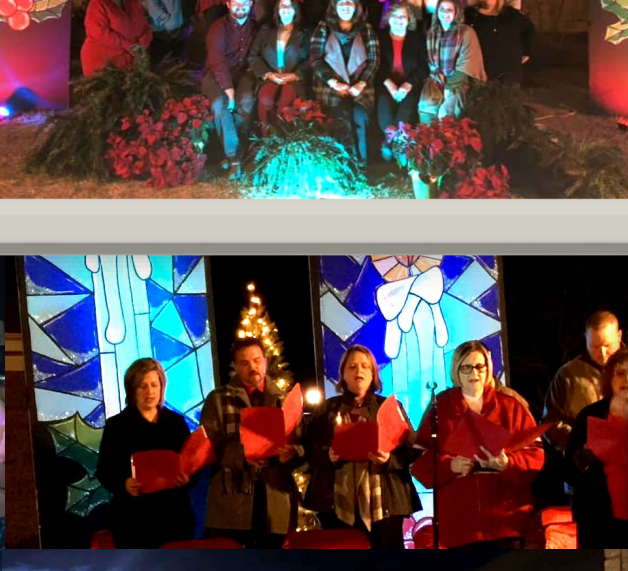

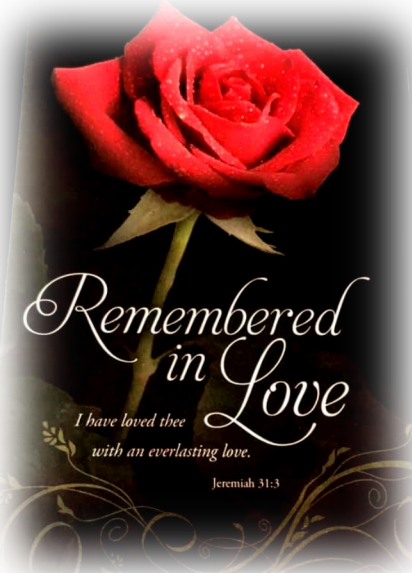

Muhammad Ali’s best quote is “Don’t count the days, make the days count;” the staff at Richmond County Hospice’s goal is to make sure the days count for every one of our patients. Hospice is about life.

So, what does, “My Hospice” mean to you?

Hospice was Medicare’s first proven coordinated care model, offering person centered, compassionate care, and ensuring people have dignity, choice, and quality of life.

Hospice every year provides care for 1.5 million Americans. At Richmond County Hospice in recent years, we have provide care for more than 350 patients in any given year. We may be small, but we are mighty. We have managed to maintain a small, independent, non-profit hospice in a rural community for 33 years now.

The Medicare hospice model involves an interdisciplinary, team-oriented approach to end of life care, quality symptom control, and comprehensive pain management. Through dedicated employees we have been able to live up to the foundation of care hospices provide through this Medicare model. We are also compassionate, provide excellent customer service, and deliver services above the hospice stand-ard. We are advocates for the patients, our community, and the hospice benefit. We see firsthand how hospice as a health care program can work because we treat the whole person and their loved ones.

As an agency we are proud of all our services and outreach into the community through our hospice program, our benevolent care, our grief support groups, Children’s grief camp, Light of Life celebrations, Hospice Sabbath, Forever Tree Ceremonies, Bingo’s at the senior centers, Salute to Veterans’ Event, Parades, and educational in-services.
