November 2017 NATIONAL HOSPICE & PALLIATIVE CARE MONTH It's about how you live.

Happy National Hospice and Palliative Care Month,

Last year the theme, "Know your options," educated the community on the differences between non-profit vs. for-profit hospices and options between aggressive treatments vs palliative/hospice care. As an agency, we spend many hours educating our community on Hospice Care. Some of the education is to dispel myths about Hospice; other times it's to educate families on the benefits of Hospice, and for Richmond/Anson Counties to promote why we are the number one choice for the best Hospice Care.

Every year, nearly 1.4 million people living with a life-limiting illness receive care from hospice and palliative care providers in this country. During Medicare's Fiscal year (October 1, 2016-September 30, 2017), RCH took care of 367 patients in our service area. We admitted 83% of the patients who were enrolled in hospice care in Richmond County and received Hospice Honors in 2015 and 2016 for our positive survey results in customer satisfaction for overall care.

In addition, during FY17, we had a 93% satisfaction rate (compared to National Average of 84%) from our customer satisfaction survey results submitted by our patients and their families giving us a 9/10 or 10/10 in overall care and a definite yes in referring our hospice services to others. We pride ourselves on our quality care, our excellence in customer service, and our mission to serve all end of life patients regardless of payer source.

This year's theme for National Hospice and Palliative Care Month is '*Qt's about how you live."* Two of the themed ads from the NHPCO for this month include "Hospice is not a place" and "Having a serious illness may not be your choice, how you live is".

Hospice is not a place. It's a special kind of care that gives you the power to live your life as you choose. To be at home. To be with loved ones. To be pain-free. To be comforted and cared for when you can no longer be cured. It's about how you live.

Did you know, that more than 90% of hospice care provided by RCH is provided in the patient's home? Only less than 10% of the hospice care that we provide is at Hospice Haven.

Having a serious illness may not be your choice... How you live is. It's about living life to its fullest. It's about receiving comfort and care, even when a cure is no longer possible. It's about surrounding yourself and your loved ones with medical, emotional, and spiritual support. Learn about palliative care and hospice. It's about how you live.

Did you know that with an earlier referral to a hospice program, patients may receive care that results in better management of symptoms, leading to stabilization of their condition and prolonged survival? (New England Journal of Medicine) In another study published in the Journal of Pain and Symptom Management, it found that patients who received hospice services lived on average 29 days longer than those who did not elect hospice care. As we have said so many times at RCH, <u>hospice is about living</u>!

According to the latest statistics available from the Hospice Association of America and the National Hospice and Palliative Care Organization:

- More than 5,300 hospices participate in the Medicare program in the U.S. From the first program that opened in 1974, hospice programs continue to grow and are located in all 50 states. RCH has strong roots in our community, sound assets, and a desire to continue providing services for another 33 years. There are other hospices that provide services in our county; however, we are the only non-profit hospice located in Richmond County and the only hospice with a GIP Unit (Hospice Haven).
- Recent statistics also indicate that around 44.6 percent of all deaths in the U.S. occurred under the care of a hospice program.

On average 50-60% of deaths in Richmond County are under the care of a hospice program. Last year, out of those deaths served by hospice in Richmond County, 83% of hospice care was provided by RCH.

• The Medicare hospice benefit, enacted by Congress in 1982, is the primary source of payment for hospice care. In 2011, the percentage of patient days covered by the Medicare hospice benefit was 87.9 percent.

At RCH, approximately 95% of care is covered by the Medicare Hospice Benefit. RCH accepts Medicaid, VA benefit and all private insurances. The benefit includes a variety of services by hospice professionals, medical supplies, durable medical equipment, medications, and additional programs. RCH as a non-profit accepts the un-insured and those who do not have the ability to pay privately for hospice care; donations through our fundraising, development, and donors provide the funds to be able carry out this mission.

 Women use hospice services more than men, and whites use hospice services more than African-Americans. Up to 83.3 percent of hospice patients are ages 65 or older. More than a third of all hospice patients are 85 years or older.
85% of our patients at RCH are ages 65 or older.

People appear to use hospices for diseases that have a high burden for caregivers, such as cancer, kidney disease, and Alzheimer's disease. End-stage heart disease, stroke, and lung disease are also common illnesses managed under hospice services.
A frequent myth about hospice care is that hospice is only for patients who have a cancer diagnosis. Any diagnosis is allowed to qualify for hospice care as long as it is a time limited-non-curable prognosis.

As we celebrate Hospice Month, let's remember those who had the vision to build a non-profit hospice in Richmond County, and for all the patients (more than 6,000) for whom we have provided care throughout the years. It takes every team member to provide the level and quality of care we do for our community. So THANK YOU to every member of our team for their compassion and dedication to our mission and for all our support from this amazing community.

Hospice Haven Expansion

Hospice Haven's addition and remodel is complete! This new addition will enhance the overall functionality of our Hospice Haven six bed inpatient facility.

The Haven was transitioned from a Residential Facility, caring for hospice patients long term as their permanent home, to a "hospice hospital" for acute short term symptom management in 2012. The hospice term for this short term care is called a General Inpatient Care (GIP). There are thirty-nine General Inpatient Centers in the state of North Carolina and 201 Hospice Agencies. We are proud that we can offer the services of a General Inpatient Center here in Richmond County. Hospice Haven cares for 25-35 patients each month.



Included in this new addition of approximately 1500 Square Feet and some additional remodeling is an Ambulance/Drop Off Pick Up Entrance with double automatic doors including cover, a laundry facility in-house with three washers and three dryers, clean linen room, storage for medical equipment, medical supplies, larger janitor's closet, pantry, outside garden storage, an office, and a new staff lounge. In addition to the new wing, some inside enhancements include fresh paint throughout the center, new flooring, updating the kitchen cabinets, and converting the old staff lounge into a family kitchen.


These new updates and addition will allow us to continue providing the utmost quality care for our neighbors who need end of life care. This enhancement would not have been possible without the Cole Foundation and the Richmond Community Foundation. Both of these organizations awarded Richmond County Hospice with a total of \$300,000 in grant monies in 2016 and 2017.
